- High School completion (copy of transcript required) OR Alberta High School Equivalency Diploma, which will be verified by transcript, or Non-Alberta equivalent of High School Equivalency Diploma
- Completion of Massage & Spa Practitioner Diploma (1000 hrs) at Canadian College of Massage & Wellness or equivalent program at another Institution (evaluation of transcripts required)
- Be 18 years of age or older (or have parent signature)
- Be willing and able to pay all course fees and purchase all course materials after being accepted to the course
- Be willing and able to attend all on-site courses or make up for missed material

No additional equipment or supplies are necessary for course completion. All supplies and equipment are supplied by Canadian College of Massage & Wellness. However, it is in the student's best interest to purchase a transportable massage table in order to practice and develop Massage skills.
